- 1. **Welcome & Call to Order** President Jeff Saunders welcomed everyone to the Fredericton Chamber of Commerce Annual General Meeting and called the meeting to order.
 - a. Approval of Agenda The meeting's agenda, minutes from last year's meeting, treasurer's report, audited financial statements, nominating committee report, list of proposed new members and a copy of the annual magazine were distributed via email prior to the meeting to all individuals who registered to attend the meeting and a copy of these items were available at the meeting. Jeff asked for a motion to approve the agenda as circulated. MOTION: David Shipley moved to accept the agenda as circulated, seconded by Mike Melvin, motion carried.
 - **b. Approval of the Minutes** Jeff asked for a motion to approve the minutes from the June 29, 2021 meeting as circulated, he reminded that the motion should be made and seconded by a member who was in attendance at that meeting. MOTION: Shannon Dion moved to approve the minutes as circulated, seconded by Bob Chisholm, motion carried.
- 2. Treasurer's Report The 2021-2022 year was another challenge to overcome for the chamber. As the year started, we thought would see the return of in-person events, and while they did return, they certainly did not return to the level we were accustomed to. Many events were planned and postponed and planned again due to the health restrictions at the time but we were able to host some events with restrictions in some cases and limited attendance in others. The chamber team worked hard through all the obstacles to spend efficiently in all budget categories. The chamber is fortunate to have had previous forward thinking boards who acknowledged the chamber's strong financial position to implement a reserve policy and set aside funds for two separate reserves. We were also fortunate to be able to apply for government assistance programs to offset our current year loss from operations. Shannon thanked the members of the Finance and Audit committee for their commitment and engagement. She also thanked the board for entrusting her with the duty of Treasurer and thanked the chamber team, in particular our bookkeeper Brianne Phillips and CEO Krista for their contributions throughout the year and ensuring we stayed on target with our finances.
- 3. **Presentation of the Audited Financial Report** Shannon reported that although the chamber was working with a new audit team this year from our audit company Shannon Buffett, the audit went very smoothly. The chamber's records are well kept and there were not a lot of year end adjustments. On page 1 of the statements is the independent auditor's report which reported a clean audit. Page 3 is the Statement of Operations which gives a picture of the chamber's revenue and expenses for the year and outlines the activity for the year compared to the previous year. In this year we did not budget for special projects as we were unsure of what the year would bring. We were able to host some strong events and that with our strong membership and advertising revenue we ended the year close to

budget. With the special projects not being in the budget, we did end the year with a healthy surplus. The statement of changes in net assets shows that the chamber is in a strong cash position. The statement of cash flows shows that receivables are a bit high and this is due to revenue being realized and events being pushed to other months. There are no liability issues. In the notes to the financial statements this breaks down the different areas of revenue as well as any changes to accounting policies. MOTION: Shannon moved to accept the financial audited report as presented, seconded by Jill Stairs, motion approved.

- 4. **Appointment of Auditors for 2022-2023** MOTION: Shannon Dion made a motion to appoint Shannon & Buffett as auditors for the 2022-2023 year, seconded by Jeff Saunders, motion carried.
- 5. **President's Report** President Jeff Saunders stated that it was an amazing year and that he has been impressed the accomplishments of the chamber team under difficult circumstances. It has been a challenging few years and the staff have handled things with grace and ease working on behalf of the members. One of the main things he appreciated this year was to be able to attend a few in-person events again and to be able to see full faces, not masked at these events. Although it has been a year of planning and postponing, our events were top notch. Jeff thanked outgoing past president Bob Chisholm for all of his hard work and commitment during a pandemic year.

We expected a decrease in members when the pandemic started but here we are going strong with 1009 members thanks to the hard work of Christine Little in signing up new members and our team, along with the board ensuring that we have very good retention. We applaud our members who have worked so hard to keep their doors open throughout the pandemic and we were excited to hear the success stories from these businesses who were able to adapt and recover. We were proud to have been able to help the business community with our strong advocacy efforts and through our workplace rapid testing program. We were all saddened to hear from

Thank you to Jeff Saunders for leading us through the second year of the pandemic and for his service to the membership and thank you to Bob Chisholm for leading us through the first year of pandemic challenges. Thank you to Betty, Beth and Kumaran for your two years of service on our board as well. We look forward to working with our new president Jill Stairs to see what the new year has in store for us.

Krista expressed her appreciation to the chamber team, Wendy, Morgan, Christine and Brianne and told those gathered that she feels fortunate to work with such a great team who is dedicated to the betterment of the business community and our members. Our staff have a combined 75 years' of Chamber experience. We wish Jude Currie the best of luck in her new position at the Fredericton Convention Centre, and thanked her for her work event planning over the past year. Krista was very pleased to announce that Adam Peabody will be joining the chamber team next week as the new event manager.

Finally Krista thanked the business community for continuing to #SupportFredLocal through spending and social media, etc. It is the combined efforts of all that help to keep the local business community thriving.


