- 1. **Welcome & Call to Order** President Jill Stairs welcomed everyone to the Fredericton Chamber of Commerce Annual General Meeting and called the meeting to order.
  - a. Approval of Agenda The meeting's agenda, minutes from last year's meeting, treasurer's report, audited financial statements, nominating committee report, list of proposed new members and a copy of the annual magazine were distributed via email prior to the meeting to all individuals who registered to attend the meeting and a copy of each of these items was available at the meeting for all attendees. President Jill Stairs asked for a motion to approve the agenda as circulated. MOTION: Noel Eustace made a motion to accept the agenda as circulated, seconded by Catherine McLatchie, motion carried.
  - b. Approval of the Minutes President Jill Stairs asked for a motion to approve the minutes from the June 30, 2022, Annual General meeting as circulated, she reminded those in attendance that the motion should be made and seconded by a member who attended that meeting. MOTION: Rodney Blanchard made a motion to approve the minutes as circulated, seconded by Gilles Allain, motion carried.
- 2. Treasurer's Report Treasurer Shannon Dion reported that the chamber had a positive year from a financial perspective and was not greatly impacted economically due to the pandemic as membership remained strong and events came back for the most part. The chamber was able to host a full complement of events including an additional Business Excellence Awards when the date was shifted to 2022- 23 to make up for the



event that couldn't be held fall 2021. Shannon remarked that the chamber staff are very good at creating their budget and do an excellent job in staying on top of expenses. Previous boards of directors have implemented reserves for an operating fund that holds up to 6 months of operating expenses and an opportunities fund which is used when extraordinary special projects and training opportunities are available. Shannon thanked the members of the Finance Audit and Risk Committee, the members of the Executive and the members of the Board of Directors for giving her the opportunity to be Treasurer. They were great sources of information and advice, and she appreciated the guidance gained from them. The comprehensive financial reporting sent to her regularly by the chamber's bookkeeper Brianne Phillips made Shannon's role as treasurer much easier. MOTION: Shannon moved to accept the annual Treasurer's report as presented, seconded by Catherine McLatchie, motion approved.

- 3. Presentation of the Audited Financial Report Treasurer Shannon Dion presented the audited financial statements as prepared by Shannon Buffett. Shannon stated that the financial statements present our situation fairly, and it was a clean audit. The Statement of Operations (Income Statement) shows that the chamber supports the business community through major events including the State of the Province, State of the City, Business Excellence Awards, Golf Tournament, as well as many other minor events. The chamber was fortunate to house the rapid testing program and received some support funding to run the program. On the expense side, it was business as usual with no big surprises. Overall, the chamber had planned on a deficit budget but was able to end the year better than the budget due to a number of factors including interest from investments. The Statement of Financial Position (Balance Sheet) shows that the chamber had a strong year. The chamber maintained strong assets, including our unrestricted assets and opportunities assets. The Statement of Cash Flows shows an influx due to investments and accruals. In the notes section, it states that the chamber has an investment policy and closely follows it to stay on track. Item 12 in the notes shows the chamber's future commitments. Shannon closed by asking if there were any questions. MOTION: Treasurer Shannon Dion made a motion to accept the audited financial statements as presented, seconded by David Shipley, motion approved.
- 4. **Appointment of Auditors for 2023-2024** MOTION: Treasurer Shannon Dion made a motion to appoint Shannon & Buffett as auditors for the 2023-2024 year, seconded by Fanny Bodart, motion approved.
- 5. **President's Report** President Jill Stairs mentioned in her comments that, unlike her last two predecessors during the pandemic, she was able to attend, in person, 2 State of the City Addresses, 2 Business Excellence Awards, a Parliamentary Breakfast and a State



of the Province Address. She was fortunate to have been able to work with community stakeholders and to attend numerous meetings, roundtables, etc. Jill mentioned that the AGM was bittersweet event for her in that she is stepping down as president, but she looks forward to working with Mike Melvin and the board in her new role as past president.

a. **Recognition of the outgoing directors** – President Jill Stairs recognized the outgoing directors and thanked them for their hard work and dedication to the chamber:

- b. Presentation of the President's Award Jill remarked that she is fortunate as President to have the opportunity to choose a member who has gone above and beyond to help the chamber in some way throughout the year. Jill awarded Shawn DeLong of Rogers Communication with the award for working with the Fredericton Chamber of Commerce and team members Krista Ross and Christine Little to produce our Business Insight Fredericton program which was broadcast on Rogers and is available on the chamber's website. Over the past several years Shawn produced, managed, filmed, and edited over 100 chamber members profiles which have been shared far and wide on social media and broadcast on RogersTVNB. Shawn accepted the award and commented how much he has enjoyed working with the chamber and learning more about our members and hearing of the challenges businesses have faced and how they've been able to overcome and prosper.
- 6. Chief Executive Officer Report Krista began her remarks by presenting a gift of thanks to outgoing President Jill Stairs. Krista reported that it has been a great year serving our members and supporting our vision of "Stronger Community Through Business Prosperity". Our chamber is the largest in New Brunswick, 2<sup>nd</sup> largest in Atlantic Canada and 1 in 20 chambers across Canada with more than 1000 members. Krista thanked Jill Stairs for being a talented president, mentor and exceptional leader. Krista also said that she is looking forward to working with Mike Melvin and the new board of directors in the upcoming year. Krista reported that #TeamChamber is a great group of professionals who focus on our members by informing them on the issues and the work

In the year 2022-2023 the chamber was highly engaged in advocacy and were busy looking for solutions for our members working with the three levels of government, community stakeholders etc. and we look forward to another busy year!

- a. Confirmation/Swearing in of President Michael Melvin, 1<sup>st</sup> Vice President / President Elect David Shipley and 2<sup>nd</sup> Vice President / Secretary Sara Holyoke. The Mayor confirmed these Executive Members with the oath of office.
- b. Confirmation/Swearing in of new board members The Mayor confirmed the new board members with the oath of office and she and CEO Krista Ross welcomed them with handshakes and Chamber lapel pins.
- c. Passing of the Buck President Jill Stairs continued the chamber's tradition of "Passing the Buck" to new President Michael Melvin. A framed one-dollar bill signed by the past presidents from the last several decades was signed and passed along.
- 9. **New Member Acceptance** In accordance with the chamber's bylaws, the membership is required to vote in all new members at our quarterly meetings and the AGM is our second quarterly meeting each year. The list of new members who joined the chamber from March 1<sup>st</sup>, 2023,fch to May 31, 2023, was circulated prior to the meeting for review. MOTION: David Shipley made a motion to accept the slate of new members, the motion was seconded by Catherine McLatchie, motion carried.
- 10. Incoming President's Report President Mike Melvin began by thanking Jill for being an exceptional president and great leader and remarked that he has some big shoes to fill. He stated that he is honoured to be the chamber's president for 2023-24 and looks forward to working with the board, executive and committees of this high performing organization. Mike commented on the excellent work of the Chamber staff, board and committees, and noted that with many organizations, a President wants to create a legacy or to leave an important milestone or mark during their term but with our well governed and managed organization his goal is to collaborate with the board and staff to refine things that we are already doing very well. He hopes to consider how the chamber can better get the message out on the work it does on behalf of the membership. The chamber's objectives are set by the business environment, and he wants the chamber to go even farther to achieve "Stronger Community Through Business Prosperity."
- 11. **Adjournment** President Mike Melvin thanked those in attendance, reminded the board of their first board meeting following the AGM and asked for a motion to adjourn the meeting, David Shipley made a motion to adjourn the meeting.
