Morgan Peters welcomed everyone and introduced President Michael Melvin.

- Welcome & Call to Order President Michael Melvin welcomed everyone to the Fredericton Chamber of Commerce Annual General Meeting and called the meeting to order.
  - a) Approval of the Agenda The meeting's agenda, minutes from last year's meeting, treasurer's report, audited financial statements, nominating committee report and list of proposed new members and a copy of the annual magazine were distributed via email prior to the meeting to all individuals who registered to attend the meeting and a copy of these items was available at the meeting for all attendees. President Michael Melvin asked for a motion to approve the agenda as circulated. MOTION: David Shipley of Beauceron Security Inc. moved, seconded by Daniel Hoyles of Snap Trade, motion carried.
  - b) Approval of the Minutes President Michael Melvin asked for a motion to approve the minutes from the June 22, 2023 Annual General Meeting as circulated, he reminded those in attendance that the motion should be made and seconded by a member who attended that meeting. MOTION: Jill Stairs of Daye Kelly & Associates moved, seconded by Jordan O'Brien of Porter O'Brien, motion carried.
- 2. Treasurer's Report Daniel Hoyles reported that he is thrilled to be the acting treasurer during the chamber's 150<sup>th</sup> year in operation. He attended the recent flag raising and it is great to be part of such a long-standing organization. The chamber is known for hosting successful, significant events such as the State of the City Address, State of the Province Address and the Business Excellence Awards celebrating our leaders in business and entrepreneurship. The staff of the chamber work had to ensure the chamber events go as planned and demonstrated exemplary adherence to budgets and ensured financial diligence throughout the year. The awareness of how changes in events could impact the chamber's finances led to efficient spending in all budget categories. Daniel expressed his heartfelt thanks to Jill Stairs. Jill has shared her deep knowledge of chamber policies and financial history with him and the board. He also extended thanks to the Finance, Audit and Risk Committee and their unwavering commitment and guidance during his tenure as treasurer. He also thanked Brianne for making his transition to treasurer a smooth one and finally he thanked the board and executive for their trust and

support during his time as treasurer and noted it has been a valuable learning experience.

- 3. Presentation of the Audited Financial Report Acting Treasurer Daniel Hoyles presented the audited financial statements as prepared by Shannon & Buffett. Daniel stated that the financial statements present our situation fairly, and it was a clean audit. The audit outlines the initiatives and events held throughout the year and there were no surprises in expenses due to the staff's strict adherence to their individual budgets. The chamber ended the year in a better than budget position attributed to the chamber's investments and accruals. Daniel asked if there were any questions. MOTION: Jordan O'Brien of Porter O'Brien moved to accept the audited financial report as presented, seconded by Jill Stairs of Daye Kelly & Associates, motion carried.
- 4. Appointment of Auditors for 2024 2025 Acting Treasurer Daniel Hoyles requested to appoint Shannon & Buffett as the auditors for the 2024-2025 year. MOTION: Michael Melvin of McInnes Cooper moved to appoint Shannon & Buffett as the chamber's auditors for the 2024-2025 year, seconded by David Shipley of Beauceron Security Inc., motion carried.
- 5. President's Report Michael Melvin began by noting that his full report is featured in the chamber's annual update magazine. He went on to say that it has been an eventful year with two major items to note. Firstly, there was a major change in the personnel of the chamber. Krista Ross was named to the Senate and stepped down as CEO. Krista had mentioned her intentions of retiring from the chamber in her first meeting with Mike as CEO. The chamber had a strong succession plan in place and the board had an easy decision to appoint Morgan Peters as the new CEO of the chamber. The chamber also welcomed Nicholas Sehl as Policy and Communications Manager. The second major item of note was the decision to form an office space taskforce to look at options for housing the chamber in the future. The taskforce decided to extend the current lease by three years and to explore options to purchase a building, possibly with rental space as a non-dues revenue stream. Mike talked about how the chamber runs as a well-oiled machine.
  - a) Michael recognized Jill Stairs and thanked her for taking such an active role in the chamber over the years. He also recognized Tosin Ajibola, Noel Eustace, Jenna Evans and Ashley Dearing for their time on the board as well.
  - b) Each year the chamber president has the opportunity to award and individual or business that has gone above and beyond for the betterment of the chamber. The President's Award is awarded to Dr. Jillian Goodyear. Dr. Goodyear has committed her time and talents beyond demanding professional responsibilities to work with the Fredericton Chamber of Commerce for the improvement of the medical resources available to fellow physicians in service of their patients and our community.

- 6. CEO Report Chief Executive Officer Morgan Peters began by thanking Michael Melvin for leading the chamber over the past year. He couldn't have asked for a better president in his first year as Michael has been involved in the work of the chamber prior to even Morgan arriving at the chamber. Morgan also recognized Sara Holyoke. Sara couldn't attend the AGM due to her ongoing health issues. We will all keep Sara in our thoughts and prayers in the days ahead with her surgery and recovery. Morgan went on to thank to board of directors for their confidence in him as CEO and he thanked Krista for mentoring him and preparing him to take on his new role. Morgan also thanked the staff of the chamber for everything they do. Morgan strongly believes in the chamber's mission to strengthening business prosperity and looks forward to working with member and to grow our community's prosperity. Morgan stated the chamber will continue to put a focus on small/medium chamber members and the 114 non-for-profit and charity members as they are a crucial part of our community. Morgan also mentioned that the chamber will continue to focus on our chamber being a diverse, inclusive organization for all business.
- 7. Presentation from the Fredericton International Airport Johanne Gallant and Kate O'Rourke of the Fredericton International Airport Authority gave a presentation on the growth importance of the airport in our community.

- c) Passing the Buck President Michael Melvin continued the chamber's tradition of "Passing the Buck" to new President David Shipley. A framed one-dollar bill signed by the past presidents from the last several decades was signed and passed along.
- 10. New Member Acceptance In accordance with the chamber's bylaws, the membership is required to vote in all new members at a quarterly membership meeting and the AGM is the chamber's second quarterly meeting of the year.
